## PASSENGER INFORMATION

### 1. Diagnostic Tests for Active Infection by SARS COV-2 that are admissible:

- a) PCR (RT-PCR for COVID-19)  
b) Fast antigen tests for SARS-COV-2 with a specificity of 97% and a sensitivity of over 80%, as approved by the health authorities in an EU or EEA country.  
c) Transcription-Mediated Amplification (TMA)

### 2. Passengers excluded from the need to isolate in their residence, temporary residence or tourist accommodation when they have chosen to carry out a PDIA within 72 hours of their arrival:

- a) Employees or self-employed workers in critical occupations, including health workers;  
b) Transport workers and transport industry service providers, including goods vehicle drivers that use their vehicle to transport goods used within the territory;  
c) Patients travelling for essential medical reasons;  
d) People who travel for urgent family or personal reasons;  
e) Public officials, diplomats, international organisation staff, and those invited by them for the essential operations of said organisations, the military and police, aid workers, and civil protection workers travelling as part of their work;  
f) Maritime workers who disembark in the Canary Islands on return from a journey or are in transit to begin or end a journey; g) Crew from air and water transport that involves passengers or goods transported between the Canary Islands or other Autonomous Communities of Spain or other countries;  
h) Journalists travelling for work purposes.

### 3. Passengers subject to check in inspection at a tourist accommodation establishment registered in the General Tourist Registry of the Autonomous Community of the Canary Islands:

- are subject to the provisions of Decree Law 17/2020, of October 29, on extraordinary measures in tourism matters to face the effects of the health and economic crisis produced by the pandemic caused by COVID-19, regarding the regime of control, documentary verification, test, isolation and corresponding measures.  
- are not subject to the AIDT and / or isolation regime established in this responsible declaration.
